PRODUCT DESCRIPTION:

Wood Treatment that causes greying for an aged effect

RECOMMENDED FOR:

All types of wood

AVAILABLE FORMATS AND COVERAGE AREA:

- 1 L : ± 60 ft² (± 5 m²)
- 3.78 L : ± 200 ft² (± 20 m²)
- 18.9 L : ± 1000 ft² (± 100 m²)

SHELF LIFE:

- Powder form: Indefinitely
- Liquid form (without Booster): 1 month in an airtight glass or plastic container
- Liquid form (with Booster): 48 hours in an airtight glass or plastic container

APPLICATION TOOLS:

Container, silk or foam brush, long pile roller, sprayer or sponge

TOOL CLEANING:

Use soapy water

DISPOSAL:

Dispose of in the sink after use (safe for plumbing and septic systems).

APPLICATION TEMPERATURE:

Between 12°C and 30°C

DRYING TIME BETWEEN COATS:

Approximately 30 minutes

COMPLETE DRYING TIME:

Approximately 3 hours

NUMBER OF COATS:

A minimum of two coats is recommended

PROTECTION:

INSTAGREY contains ingredients to protect against mold and rot, preserving your wood longer

COMPATIBILITY:

INSTAGREY is compatible with all types of varnishes, sealants and epoxy.

- Results may vary depending on the type of wood used.
- INSTAGREY is effective only on wood.
- Bamboo is a grass, not a tree, so. INSTAGREY treatment is not compatible.
- Do not use on metal surfaces.
- INSTAGREY is not recommended for treated wood surfaces. The chemicals used in treated wood form a barrier preventing the product from achieving optimal results. There, may be a slight discolouration.
- INSTAGREY does not contain UV protection. Colour may change over time depending on exposure.
